#### What Does an Account Do?



# Save for qualified disability expenses while maintaining eligibility for public benefits.



With an ABLE United account, an individual has the opportunity to save up to \$15,000 a year without impacting public benefits or eligibility for future benefits.

## How Does an ABLE Account Work with Public Benefits?



#### **Specifics on Medicaid**



- Medicaid is a federal and state program that helps with medical costs for some people with limited income and resources.
- There is also Medicaid iBudget Waiver, which provides home and community-based supports and services to eligible persons with developmental disabilities living at home or in a home-like setting, utilize an individual budgeting approach, and provide enhanced opportunities for self-determination.
- When it comes to ABLE accounts, funds in (or withdrawn from) an account are disregarded when determining eligibility for Medicaid.



#### Specifics on Supplemental Security Income (SSI)



- Supplemental Security Income (SSI) is a Federal supplement program that provides cash to meet basic needs for food, clothing, and shelter.
- Like Medicaid, SSI has a resource limit of \$2,000 and generally, funds in (or withdrawn from) an ABLE account are disregarded when determining eligibility.
- When it comes to ABLE accounts, individuals receiving SSI are able to save a total of \$100,000 before it counts as a resource.
- Funds withdrawn and retained for housing may count as a resource in subsequent months.



#### Who Qualifies for an Account?



#### Eligibility

Eligible individuals are allowed one ABLE account nationwide and must also:

- Be a Florida resident
- Have a disability with onset prior to age
  26
- Have a disability that is "severe"



#### Eligibility

 A qualifying disability includes individuals with a diagnosis such as Down syndrome, autism, cerebral palsy, cognitive, developmental or mental health disorders

- An individual receiving Supplemental Security Income or Social Security Disability Insurance automatically meet this requirement
- If you're unsure if your disability qualifies, we recommend utilizing our online eligibility wizard



#### How Do You Enroll?





#### **Enrollment Process**

- 1 The date of birth, address and Social Security Number for the individuals on the account
- Documentation of Power of Attorney or Legal Guardianship for an adult beneficiary (if applicable)

- **3** Banking information
- 4 Minimum \$25 contribution to the account
- **5** Investment selections

Also, if you're working and not currently saving for retirement through your employer, you may also be able to save above the annual contribution limit and take advantage of the Saver's Credit.



## How Can You Access Funds in Your Account?



#### Withdraw

#### Checking and Savings

Transfer to personal checking or savings account

#### Check Request

Check can go to beneficiary, administrator or a third-party

#### ABLE Prepaid Card

Transfer funds onto your ABLE Card



## **How Much Does it Cost?**



#### **Costs Associated**

#### It's free to open an ABLE United account.

#### There is no:

- Application fee
- Account maintenance fee

All you have to do is to put in a minimum contribution of \$25 to get started and let your money make money for you.



#### The Rainy Day Campaign

With ABLE Accounts often referred to as rainy day funds, we're encouraging the disability community to start saving with our Rainy Day Campaign.

Now until June 30, when an individual completes enrollment online and contributes a minimum of \$25, they will receive **\$50** on us.


There are laws against discrimination in the rental or sale of housing on the
