DECLARATION OF DR. JEFFREY GOLDHAGEN, MD MPH

COMES NOW, Declarant JEFFREY GOLDHAGEN, M.D., MPH, and pursuant to 28 U.S.C. § 1746, declares the following under penalty of perjury is true and correct:

1. My name is Jeffrey Goldhagen, MD, MPH. I am a Professor of Pediatrics and Chief of the Division of Community and Societal Pediatrics at the University of Florida College of Medicine-Jacksonville, and President of the International Society for Social Pediatrics and Child Health (ISSOP). I was also the former director of the Duval County Health Department. I have extensive experience in domestic and international maternal and child health; urban health; medical education; the core functions of public health; health care administration; care of children with complex medical conditions; hospice and palliative medicine; and in child rights and advocacy. I have provided leadership nationally in the development of comprehensive public health systems and systems of care for children's medical and behavioral health—in particular children marginalized by complex medical conditions and social and environmental conditions. As the President of ISSOP, I am currently working with a global consortium of professionals and

organizations to advance the health and well-being of children—including addressing issues of

violence against children, migration, globalization, and climate change.

2. My CV is attached hereto as "Exhibit A"

3. I am familiar with the studies and articles regarding the transmission of COVID-19

amongst children, including children with chronic illness, or developmental or intellectual

disabilities.

4. With respect to COVID-19, much has been learned globally about the

epidemiology of the disease and how to prevent its spread. In particular, the Delta variant, which

is currently the predominant strain of circulating Covid-19 virus in Florida, is significantly more

contagious than previous strains. Also, data is accumulating to indicate it may cause more serious

disease outcomes--especially in children. This is especially true for children with disabilities that

make them more susceptible to becoming seriously ill or die due to COVID-19 infection.

Knowledge of the scientific evidence-base accumulated through the course of the pandemic, and

adherence to the recommendations of the American Academy of Pediatrics, Centers for Disease

Control, World Health Organization, and other reputable sources will be required to open our

schools safely and prevent the spread of the disease among students, staff and the community.

These recommendations include universal masking in all indoor places for individuals over 2 years

of age, social distancing, disinfection of surfaces and ultimately--vaccination.

5. The evidence-base is definitive that masks work to prevent the spread of COVID-

19, including the spread of disease in schools. Parents would not let their children swim in a toxic

swamp. If they allow their children to enter indoor environments in which all people are not

masked--including schools, supermarkets, gyms, libraries, restaurants, etc., they are allowing their

children to enter into a potential toxic swamp of COVID.

6. Impact of Covid-19 on people with Developmental and Intellectual Disabilities

The Covid-19 pandemic has and continues to have a profound and disproportionate direct and indirect impact on the health and well-being of children with developmental and intellectual disabilities.¹ Nearly 20 percent of children are challenged by DD—in Florida this represents approximately 800,000 children under the age of 18.² Data on the direct impact indicate:

- COVID-19 incidence is 3 times greater among patients of all ages with intellectual disabilities than those without, with 6 x the mortality rate.³
- Children with Autism Spectrum Disorders, Intellectual Disabilities, Learning Disabilities and ADHD are 3-9 times as likely to be hospitalized.⁴
- The case fatality rate for children with DD less than 17 years of age compared to those without DD is more than 10-fold higher.⁵

With respect to the indirect impact of Covid:

• In a survey of more than 3,000 caregivers of children with ASD, 62% reported moderate to severe negative impacts of COVID-19-related disruption in services on their child's

ASD symptoms and 72% reported experiencing moderate to extreme stress due to these disruptions.⁶

- In another study, 44% of parents reported low satisfaction with their child[ren]'s therapy services during the pandemic. ⁷
- A more qualitative study by Frameworks Institute found:
 - 1) Children with special needs are going to fewer wellness visits and receiving fewer vaccinations than other children;
 - 2) Caregivers of children with special needs have fewer social supports than other caregivers; and
 - 3) Both caregiver and child mental health is suffering in families with a child with special needs, with no signs of improving as the pandemic continues.⁸

7. Covid-19 Delta variant: Transmission and Virulence

The above findings generally reflect the impact of the initial and Alpha strains of SARS-CoV-2 disease. The impact of the Delta variant of SARS-CoV-2 on children with ID and DD will be far greater due to its greater transmissibility and virulence. With respect to transmission and virulence:

- According to the CDC, the Delta coronavirus variant surging across the United States spreads as easily as chickenpox. Thus, it has a R0 value of 9-10, meaning that one person will infect 9-10 people without proper protection.
- An oft-quoted study from China indicates the viral load in patients with the Delta variant may be 1000x greater than individuals infected with the initial and Alpha variants.⁹

- In a study in Singapore, Delta variant infections were associated with higher odds of oxygen requirement, ICU admission, or death. 10
- A Canadian study found that "The progressive increase in transmissibility and virulence of the SARS-CoV-2 Delta variant will result in a significantly larger, and more deadly, pandemic than would have occurred in the absence of its emergence.¹¹
- A study in Scotland found the Delta variant to be twice as likely to result in hospitalization. 12

8. Covid-19 in Children

The transmissibility and virulence of the Delta variant is resulting in a dramatic surge in the number of children infected with SARS-CoV-2 and the severity of the illness it is causing.

According to the American Academy of Pediatrics:


- As of August 19, over 4.59 million children have tested positive for COVID-19 since the onset of the pandemic. Over 180,000 cases were added the past week, reaching levels of the previous winter surge of 2020-21.
- After declining in early summer, child cases have increased exponentially, with over a four-fold increase the past month, rising from about 38,000 cases the week ending July 22nd to 180,000 the past week.
- Since the pandemic began, children represented 14.6% of total cumulated cases. For the week ending August 19, children were 22.4% of reported COVID-19 cases. In Florida, this increase is dramatically presented in the following graph.

Hospitalizations are increasing dramatically as well.

- At the end of July, Florida led the nation in kids hospitalized for Covid-19, with 32 pediatric hospitalizations per day between July 24 and 30. (Centers for Disease Control and Prevention (CDC))
- Wolfson Children's Hospital has had a 500% increase in the number of children recently hospitalized in comparison to previous pandemic peaks.
- At Joe DiMaggio Children's Hospital in Broward County, pediatricians treated just over 20 children with COVID-19 in June and more than 240 children with COVID-19 in July. In just the first 10 days of August, they treated 160 children with COVID.
- The CDC's latest COVID-19 review shows hospitalization rates for kids 4-years-old and younger have more than tripled since the last week of June. As of October 1, 2020, the number of patients with MIS-C in the United States surpassed 1,000. In 2021, this number surpassed 2,000 as of February 1, 3,000 as of April 1, and 4,000 as of June 2nd. and as of July 30: 4404.
- 9. The dramatic surge in the number of children infected with Covid-19 is in part due to the transmissibility of the Covid-19 Delta variant. The dramatic surge in the number of children who are being hospitalized with Covid-19 is due to the increased virulence of the Delta variant in comparison to the initial and Alpha strains. The reason for the dramatic increase in rates of disease and hospitalizations among children in Florida and other Southern states is in part due to the failure to implement transmission prevention strategies, in particular, wearing masks.

10. Given the R0 value noted above that is the same as chicken pox, as reported

by the CDC, it is reasonable to assume that an infected child in a confined indoor space would

infect approximately 9 other children and adults if all were unmasked. Based on a number

of studies, some of which are reported in AMA Insights, mask wearing will prevent between

70% and 100% of infection transmission. 13 The overall community benefit of wearing masks

derives from their combined ability to limit both exhalation and inhalation of infectious virus.

Thus, it is critical that mask wearing be universal.

11. As detailed above, children (and adults) with developmental and/or intellectual

disabilities are at substantially greater risk for becoming infected and for developing severe disease

requiring hospitalization. These data relate primarily to infection with the initial and Alpha strains

of SARS-CoV-2. It is reasonable to assume that the risks will be even greater with the spread of

the Delta variant.

12. The large and steady numbers of children who are being infected and hospitalized

are presented above—more detailed information is available through the CDC and American

Academy of Pediatrics. Without mitigation strategies, which includes masks, social distancing,

and disinfecting, those numbers will continue to increase—until a steady state is reached due to

the prevalence of those who have been infected and thus have a degree of immunity, and/or those

vaccinated. To reach this steady state, many children will suffer from acute illnesses and endure

long-haul Covid, and some will die. Children and youth with developmental and/or intellectual

disabilities will be amongst children with the greatest risk. This is due to their activities of daily

living that place them at risk for contracting the disease, as well as the number of co-morbidities they endure that are associated with their disabilities. Many of the genetic and root causes of their disabilities are also associated with medical conditions that place them at increased risk of contracting Covid-19 and developing severe disease.
